 - 1. Eleven (11) out of Twenty (20) departments are deficient in faculty/Resident/tutor as per AEBAS record data: Anatomy, Anesthesiology, Biochemistry, Community Medicine, Forensic Medicine & Toxicology, Microbiology, Obstetrics & Gynaecology, Orthopaedics, Pharmacology, Physiology & Psychiatry.
 - 2. Clinical Investigations: Clinical Pathology is inadequate.

Subsequently, the compliance report submitted by your Institution was also evaluated by the Assessors; however, amongst other deficiencies, following key deficiencies were again highlighted w.r.t. your College/Institution:

1. Some Departments are still deficient in faculty/Resident/tutor as per AEBAS
